## **AFFILIATED UNIVERSITY COLLEGES**

The three affiliated university colleges—Brescia (Canada's only Women's University), Huron (Western's founding institution), and King's (a Catholic, co-ed University)—are residential, liberal arts colleges specializing in student-centred education. Each campus offers students the advantages of a small campus in the context of a large, world-class, multi-faceted university. The campuses are academic units of Western and maintain the same academic standards. Affiliated University College students enjoy all the rights and privileges as the main campus student body, can participate in Western's extracurricular activities, athletics, and health services and, most importantly, receive their degrees from Western. Applicants to one of the affiliated university colleges are eligible for the admission scholarships and residences of that campus. Students who wish to be considered for admission to an affiliated college, must specify the particular program and campus as one of their choices on the OUAC application. ### PREREQUISITE COURSES

#### **FACULTY OF ARTS AND SOCIAL SCIENCE**

Bachelor of Arts, Honors Specialization/Honors Business Administration Combined Degree Program In Year 1, students must complete the admission requirements for entry into a Bachelor of Arts, Honors Specialization module offered by the Faculty of Arts and Social Science at Huron University College. To be considered for admission to this combined program, students must complete a minimum of 10.0 courses including Business Administration 2257 and the required second year courses for a Bachelor of Arts, Honors Specialization module in the Faculty of Arts and Social Science at Huron University College. A minimum of 5.0 courses must be taken in each of Years 1 and 2. Students apply for the combined degree program during the HBA 1 year, typically their third year of University.

In Year 2, students must enroll in a Bachelor of Arts, Honors Specialization module offered by the Faculty of Arts and Social Science at Huron University College and achieve a minimum 70% modular average. They must also gain admission to the HBA program through the regular application process. In addition, students must normally attain a minimum weighted average of 78% in the first year of the HBA.

Anthropology, Economics, English, Geography, History, Philosophy, Political Science, Sociology, and Women's Studies are recommended as first year courses.

Honors Specialization in Global Gender Studies

Completion of first-year requirements with no failures. Students must have an average of at least 70% in 3.0 principal courses: 1.0 course from Women's Studies 1020E, 1021F/G, 1022F/G; 1.0 course from Centre for Global Studies 1021F/G, 1022F/G, 1023F/G; plus 1.0 additional course, with no mark in these principal courses below 60%. Note: Students beginning this module after first year may substitute Women's Studies 2240F/G in place of Women's Studies 1020E and take it concurrently with their second-year courses.

Honors Specialization in Global Health Studies Completion of first-year requirements with no failures. Students must take 3.0 principal courses, achieving an average of at least 70% across them and with no final grade of less than 60% in any of them. These principal courses must include the following 2.0 courses: 1.5 courses: Centre for Global Studies 1023F/G; Health Sciences 1001A/B, 1002A/B; 0.5 course from: CGS 1021F/G, 1022F/G. The remaining 1.0 principal course and the other 2.0 first-year courses may be taken from across the Humanities, Social Sciences, and Sciences. Geography 1400F/G, 1500F/G, and Sociology 1020 are recommended to satisfy prerequisites needed in the module.

Honors Specialization in Global Rights Studies

Completion of first-year requirements with no failures. Students must take 3.0 principal courses, achieving an average of at least 70% across them and with no final grade of less than 60% in any of them. These principal courses should include at least 0.5 course from Centre for Global Studies 1021F/G, 1022F/G, 1023F/G and 1.0 course from Women's Studies 1021F/G, 1022F/G, 1024F/G. It is recommended that the remaining first-year courses may be taken from Anthropology, English, History, Philosophy, Political Science or Sociology.
